2. EC Bylaws

- Chair Moreno initiated a discussion regarding the executive committee selection process outlined in current bylaws.
 - o Commissioner Ruiz- Chair shouldn't appoint EC, should be a whole commission vote
 - Each EC has a role: secretary, treasurer etc.
 - O Commissioner Garza- What would those roles be?
 - Financing role is staff responsibility
 - Current committees helps us focus on our areas of expertise
 - Wants to keep the current structure
 - How are other commissions structured in comparison to CHA?

- o Commissioner Ruiz: think it's similar to other boards where treasurer/CFO exists
 - There's an idea of checks & balances
 - Not responsible for finance or notes but serve as oversight
 - Separating them gives the commission opportunities for leadership role
- Commissioner Garza what are you comparing boards to? CHA is an government advisory boards different from corporations and non-profits. We cannot model our commission based off them.
 - Commissioner Ruiz modeling off of Robert's Rules
 - Seen on councils a standard practice
- Commissioner Ahumada commission historically does not handle finance. Not the commissioner's role.
 - Commissioner Ruiz- placed in the rules about funding handled by staff (?)
 - The position would serve a check and balance
- Commissioner Hernandez interested in Commissioner Ruiz' proposal as used to working with nonprofit
 - How do we compare to other commissions?
- Commissioner Perez
 - Doing research not comfortable making a decisions without having a formal comparisons of options
